From Rosslyn Jacob Edwards, Executive Director



Once again Dance Ontario enjoyed a busy, productive and gratifying year, due in no small part to the completion of activities related to the Ontario Trillium Foundation funded Connecting The Dots project. Through this initiative, we partnered in the establishment of three regional dance networks - Halton (HDN), Dufferin (DDN) and London (LDN) - took dance to North Bay for the 2014 Pulse Youth Conference with CODE, to **London** for the *Flux Contemporary Dance Festival*, and showcased artists to delegates at the COCA (Corporation of Campus Activities) conference in Niagara Falls. Most incentives also included dance forums or information sessions with communities that raised profile for both Dance Ontario and the artists we represent.

We hope that we will be successful in raising funds to establish three <u>additional regional networks</u> over the next two years and that these activities will culminate with a gathering of all six networks to share experiences and build stability for their local dance communities while establishing hubs of importance to touring artists.

DanceWeekend'15 thrilled patrons with stunning programs from member companies highlighting the incredible diversity of dance forms and artists inspired by cultures from across the globe. Toronto Star writer Michael Crabb acknowledged the importance of our Commissioning and Creative Partnership Program spotlighting the work of independent creators at this truly unique event that provides access across physical, economic and cultural borders. Several commissioned artists have been nominated for Dora Mavor Moore Awards and many have become popular works in those artists' repertoires. In January 2015 we live-streamed one day of the event to a regional community for the first time—a collaboration with the Dufferin County Museum and the DDN.

Dance Ontario welcomed almost 60 new members attracted by our reliable delivery of core services including website updates, publication of e-bulletins, 'headlines' and The Directory , in addition to provision of SOCAN fees at affordable rates. The Board of Directors continued to bring an extraordinary diversity of expertise to our meetings as they monitored activities, provided governance and worked with staff to bring forward and identify new needs and issues within the various sub sectors.

We believe 2015/16 will prove equally exciting and , as always, welcome input from you, our members.
